Whereas considering the trend of development and sensitivity of the area, SADA Reckong Peo has been included under the purview of Himachal Pradesh Town and Country Act, 1977, vide notification no. लो नो (V) 26 (162) /87 dated 17-10-1989 by the Govt. of Himachal Pradesh. The notification was issued in the context that due to the historical & religious importance of the area, people from different parts of the country visit this place every year and to provide facilities to the tourists, pilgrims, and general public, its prospective planning, regulated and controlled growth was inevitably necessary. The said area is constituted by eight Gram Panchayats of Block- Kalpa, Distt. Kinnaur ie. Gram Panchayat Khawangi, Gram Panchayat Kothi, Gram Panchayat Telangi, Gram Panchayat Kalpa, Gram Panchayat Shudharang, Gram Panchayat Pangi, Gram Panchyat Yuwarangi & Gram Panchayat Duni.

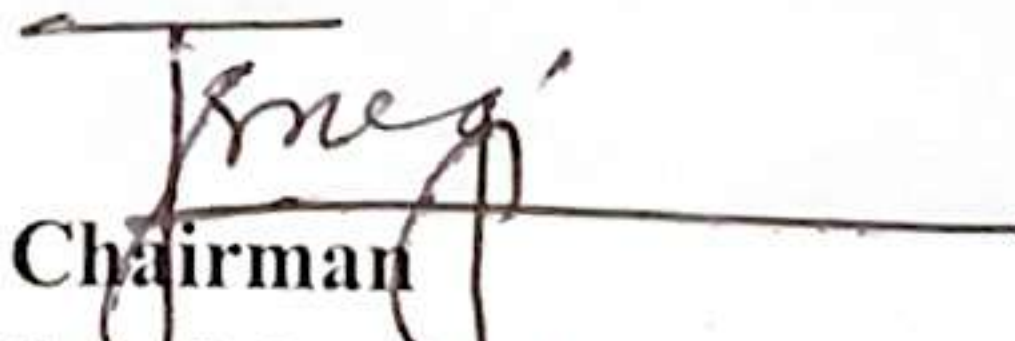
Whereas, a meeting of general house of SADA Reckong Peo was held in the chairmanship of the undersigned on dated 05-06-2025. Various members of the house raised issues regarding increasing tourist inflow in the SADA Reckong Peo area and thus the rising problems of solid waste management, sewage management, fragile ecology of the region. Besides, the members of the SADA house also raised the issue of lack of financial resources with SADA Reckong Peo to meet out these pressing problems which need to be addressed immediately in public interest.

And whereas, the general house of SADA Reckong Peo passed a unanimous resolution that a fee be charged from all the vehicles from other states and all commercial vehicles of Himachal Pradesh (except those bearing registration numbers of Distt. Kinnaur) entering SADA Reckong Peo for the resource mobilization of SADA Reckong Peo to address various issues of ecological/environmental conservation, develop infrastructure/mechanism for effective disposal of solid waste and promote sustainable tourism in the region.

Therefore, in continuation of the previous Notification No. SDK(SADA)-Fee Barrier/2025-157, dated 06-06-2025, I, Jagat Singh Negi, Hon'ble Minister of Revenue, Horticulture, Tribal Development and R.P.G., Government of Himachal Pradesh, in view of the circumstances stated above, and the resolution passed by SADA Reckong Peo, in exercise of the powers vested in me as Chairman, SADA Reckong Peo, under Section 71(C) of the Himachal Pradesh Town and Country Planning Act, 1977 (which confers upon SADA the powers of a Municipal Council as per the Himachal Pradesh Municipal Act, 1994), read with Section 66 (regarding fees, tolls, and user charges) of the Himachal Pradesh Municipal Act, 1994, do hereby order that all commercial vehicles of Himachal Pradesh (except those bearing registration numbers of Districts Kinnaur) entering the SADA Reckong Peo area shall be levied a SADA Development Fee as per the following rates:

- a) Two wheelers = Rs. 50/-
- b) Cars = Rs. 100/-
- c) SUVs, MUVs = Rs. 150/-
- d) All kinds of buses/ trucks = Rs. 200/-

This order shall come into effect immediately. The 'terms and conditions' regarding utilization of this fee shall be as per the guidelines issued separately.
